For new events, on October 4th we offered a pet blessing. Why October 4th? Because it is the memorial of St. Francis of Assisi. This fall, October 4th falls on a First Friday when we have Adoration. We will end Adoration at 5:30 pm. Then, we will offer the pet blessing Friday, October 4th at 6:00 pm by the St. Francis statue in the courtyard at St. Mary's.



Last October, we also offered the first Mass in Spanish in Schuyler County. There is a growing population of Spanish speaking people here. The third Corporal Work of Mercy is to welcome the stranger (Leviticus 19:34, Matthew 25:35). Recognizing how most of our families started with immigrants to the United States, we want the Spanish people to feel welcome. The first Mass was offered at Bergen Farms in Odessa. Another Mass was offered at Gates Farm near Burdett. In January of this year, we made a Spanish Mass a regular monthly event at St. Benedict's on the second Sunday of each month at 7:30 pm. The Mass is followed by a meal cooked by one of the Spanish attendees. I do not speak any Spanish. So, we are grateful that Fr. Brendan Buckley, O.F.M. Cap. is available through the diocese (who pays his salary) to offer these Masses.

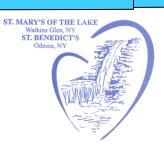
The year also came with some challenges. On Holy Thursday, the sound system at St. Mary's died just as we began Mass. It turned out two amplifiers had died. It took three or four weeks to make the replacements. So, we are very grateful to two families who lent us portable amplifiers while we waited for the repairs. We were blessed to have plenty of money in our Memorial Account to cover the \$4,000 bill. The Memorial Account is where we place donations given in memory of a deceased person. We thank those who have given to this fund.

We also had an intermittent water and odor problem in the Parish Center at St. Mary's. Because it was intermittent, it took us some time to identity the cause. It turned out the sewer line outside the building was 99% plugged due to a shift in the pipe underground. It cost St. Mary's \$13,000 to complete the necessary work followed by \$1,780 to replace blacktop.

Faith Formation for Children and Youth

This year we continued with the same model for our faith formation activities for children and Confirmation preparation. We had two young boys, Noah and John, make their First Reconciliation in December and their First Communion on May 5th. We are delighted to have them join us at the table of the Lord. We had six teens complete year one of our two year Confirmation preparation program. They should be confirmed in Spring 2025.

Last December Deacon Dan Pavlina began a new assignment closer to his new home. With this, Fr. Jeff took responsibility for the baptismal preparation classes for parents who desire to have their infants baptized.

Then, in May, Rosemary Nabogis retired. We are grateful for her ministry with us since 2018. She began as Pastoral Minister and Cemetery Coordinator. In 2021, the faith formation duties were added to her responsibilities. She absorbed it with love and care for the children. We thank her for her ministry here and pray for her future endeavors. We have been seeking to fill her position since her departure without success. Now, because of the budget deficit, Fr. Jeff has decided to change the position to a part-time faith formation only. Fr. Jeff will oversee faith formation until a replacement has been hired.

St. Mary's and Holy Cross Cemeteries

As COVID swept our nation, the number of funerals rose from 19 to 31, peaking at 36 in 2022. Thankfully, the numbers have fallen slightly to 30.

As the 2023-2024 fiscal year began, we made an adjustment in our cemetery operations. St. Mary's Cemetery was previously mowed by our church maintenance person but we had been unable to fill that position. So, we hired a contractor to mow St. Mary's Cemetery. At the same time, the parishioner who was taking care of the mowing at Holy Cross Cemetery was no longer able to do so. So, the same contractor was hired to mow at Holy Cross Cemetery. We hired the same contractor for this year. We had some issues in May 2024 with the timing of mowing but we worked through them. This was pure logistics. A special note from Fr. Jeff—we learned of some of the issues through third hand comments. If you have concerns about the cemeteries, please call me first.

Because of your generosity in our two annual second collections for our cemeteries and an *unusually high* year for grave sales, we now have funds to accept bids to complete some much needed drainage work. One might think on top of a hill the water would run off easily but the clay soil holds the water causing water issues when digging graves and excessive settling in new graves.

From Fr. Jeff A Common Misconception About St. Benedict's

In the last three months I have received a few comments from parishioners who think that if we close St. Benedict's that it would be a financial gain for St. Mary's. I am concerned that this is based on a mistaken idea that St. Benedict's does not have enough money to pay its bills because attendance at Mass there averages between 40 and 60.

These attendance numbers are correct. However, that does not mean St. Benedict's does not have enough money to pay its bills. For the last fiscal year, St. Benedict's had an operating deficit of \$3,300 out of expenses totaling \$65,956 (5%). It would have been about \$1,500 better except in June a number of parishioners were away. So we did not receive their normal contributions. They have returned and caught up on their contributions in July in the new fiscal year. *This is the first time St. Benedict's had a real deficit*. St. Benedict's has more than enough to cover this deficit in their checking account. Here, I will note that the largest portion (\$44,956) of St. Benedict's budget is to help pay for the salaries and benefits of our combined staff.

I understand that it might still seem prudent to close St. Benedict's to save on the building expenses and property insurance. These totaled \$14,845 last year. If we were to close St. Benedict's but were unable to sell the building, these expenses would not change significantly.

However, if we close St. Benedict's it is likely the income from parishioners who attended St. Benedict's until it closed would *decrease*. Why? You might think if St. Benedict's closed, all those who go there would automatically come to St. Mary's. However, it is likely, and common when churches close, that some of the people who historically attended St. Benedict's would NOT attend St. Mary's. Typically there are some who stop going to church. Others might attend a different church such as St. Mary our Mother Church in Horseheads as some of them have Horseheads addresses.

For our fiscal year 2024-2025, while both churches face deficits, it is actually St. Mary's that has the bigger issue of not having enough income. St. Benedict's faces a deficit of \$4,800 out of \$67,332 (7.1%) while St. Mary's faces a deficit of \$36,000 out of \$367,500 (9.8%).

How is it that St. Benedict's is doing better? They have some very generous parishioners both in money and in volunteering. For instance, St. Benedict's parishioners clean their church as volunteers. St. Mary's has had a part-time cleaning person for 15 hours/week. This costs St. Mary's \$16,500 each year.

Please note that we are working on ways to help all our parishioners be better aware of our financial challenges and are always open to input/ideas for strengthening us in the future.

Please pray we find a way to bring more people to both churches. It is the people we care about. If we do get more people to church and they give to the collection, then we would be in better financial shape.

Definitions:

Restricted—These funds were given for a specific purpose specified in writing.

Stable Patrimony—These are our long-term investments that we have accumulated over the years. There has been no new money added in over 10 years. Last year \$87,000 was withdrawn from St. Mary's of the Lake to cover St. Mary's share of channeling injunction costs. No money has been withdrawn from St. Benedict's since 2013.

Total Fund Balance—This number represents our net assets.

How Are Our Finances?

Fr. Jeff Shares His Thoughts on the Finances

The 2023-2024 fiscal year was the first year both our parishes had operating deficits. These are due to increase in salaries (*barely* matching the rate of inflation), benefits, and insurance. We are working hard to eliminate the deficits *at both parishes*.

FINANCIAI

St. Mary's began the year with a budgeted deficit of \$55,450. During the year we were **blessed** with a \$40,000 donation from an estate of a *former* parishioner. We are very fortunate to have received this but we cannot build a future dependent on such gifts. Some years we do not receive any bequests. When we do, it is typically \$500—\$1,000. With this \$40,000 bequest we ended this year with a surplus of \$24,004. Without this bequest, the deficit would have been \$15,996. This deficit included the \$17,000 of unexpected repairs I mentioned on page one. The final deficit would have been far worse if parishioners had not increased their contributions to St. Mary's by \$20,685 (8.2%). The deficit was also alleviated by the fact that we have not had a paid cleaning person since January and a without a Pastoral Minister on staff for most of May and all of June and remain so. This is a significant savings but *we cannot maintain the faith formation program without some help (paid or volunteer)*.

St. Benedict's began the year with a budgeted deficit of \$2,400. It ended the year with an operating deficit of \$3,300 out of expenses totaling \$65,956 (5%). (Please see page three for more on St. Benedict's finances.) *This is the first time they have had a real deficit*. St. Benedict's has more than enough to cover this deficit in their checking account. I will note that the largest portion (\$44,956) of St. Benedict's budget is to help pay for the salaries and benefits of our combined staff.

Please note that these deficits include salaries and benefits for a full-time Pastoral Minister. Going forward, if someone becomes available we would still hire a part-time faith formation coordinator but we will try to continue without this being a full-time position. The cleaning position being vacant for July and August has saved approximately \$2,600. Having no one in the pastoral minister position for July and August has saved around \$9,750. Adjusting to the position being part-time (20 hours/wk (no benefits)) for the remainder of the year *could* save another \$23,200, resulting in a total savings for the year of \$35,550 between the two parishes.

I'm sure you are wondering about the status of the diocesan bankruptcy and sexual abuse lawsuits. Earlier this summer the diocese reached an agreement with the victims attorneys and most of the insurance companies. This plan is being voted on now by the claimants. If it passes, we could end the bankruptcy in the next few months. We already paid our anticipated portion to escrow in the 2022-2023 fiscal year (St. Mary's—\$152,190, St. Benedict's—\$27,297). The attorneys representing the parishes in the lawsuits will need to be paid a small amount of additional legal fees as the bankruptcy concludes (assumes the agreement passes the victims' vote and the judge approves). I know that some people feel the parishes should not have to pay anything. Knowing we have victims in our parish, how much do you think we would have to pay to settle lawsuits on our own? Do not blame the victims. They did not choose to be victims. Thankfully, we had money in reserves to cover this and still have money left over. Let us pray that no one, in or outside the church, is ever victimized again.

Please be assured of my continuing efforts and those of our Business Manager, Terri Orbin, Finance Director, Donna Haraty, and our Finance Council as we work to ensure the financial fitness of our parishes. Peace,

Here is your annual report of parish life and finances for St. Mary's of the Lake in Watkins Glen and St. Benedict's in Odessa.
